Parade Invitation and Participation Agreement

Between

St. Patrick's Parade Committee of Manchester, Inc.

And

Participating Organization Deadline for Acceptance: **February 3**

The undersigned Participating Organization understands:

This Invitation to participate in the Manchester St. Patrick's Parade (hereafter referred to as **the Parade**) is conditioned on the express agreement of the above-named, undersigned Participating Organization (hereafter referred to as the **Organization**) as invitee to comply with all Regulations of the Saint Patrick's Parade Committee of Manchester, Inc. (hereafter referred to as the **Committee**).

The deadline date for acceptance of this Invitation is above. If this Parade Invitation and Participation Agreement is not fully completed and returned to the **Committee** by such date, it will indicate the **Organization** may not plan to participate in the **Parade**, which means the **Organization's** place in the Parade may be assigned by the **Committee** to an alternate invitee.

The **Organization** recognizes that the **Committee** on the day of the Parade has authority to interpret its established Regulations and Policies, determine compliance therewith and take appropriate action to enforce such Regulations.

The **Organization**, for itself and on behalf of its members, employees, agents, volunteers and others who may participate in **the Parade** as part of its **Organization**, in consideration of its participation and in consideration of any support that may accompany such participation, agrees:

To not sue or assert a claim against the **Committee** and its individual members on account of any occurrences on the day of the Parade or prior to the day of **the Parade** or in connection with Parade activity;

Parade Invitation and Participation Agreement (cont'd)

To indemnify and hold harmless the **Committee** and its individual members from and against any and all actions, claims, damages, injuries, losses, penalties of every name and nature whatsoever arising from or in connection with the **Organization's** participation, or in the preparation of participating in the **Saint Patrick's Parade**.

To furnish the **Committee** with a **Certificate of Insurance**, prepared in conformity with the enclosed sample Certificate, affirming that the **Organization** is insured by a Policy of General Liability Insurance from an approved insurance company for a minimum of **\$1,000,000** single limit of liability. Said Certificate should also affirm the Organization carries Workers Compensation Insurance to cover any personnel who work for or provides services to the **Organization** related to the Saint Patrick's Parade.
