Parade Invitation and Participation Agreement

between

St. Patrick's Parade Committee of Manchester, Inc.

and

Participating Organization

Deadline for Acceptance: **February 8, 2020**

The undersigned Participating Organization understands:

This Invitation to participate in the **March 29, 2020 Manchester St. Patrick's Parade** (hereafter referred to as the **2020 Parade**) is conditioned on the express agreement of the above-names, undersigned Participating Organization (hereafter referred to as the **Organization**), as invitee, to comply with all Regulations of the Saint Patrick's Parade Committee of Manchester, Inc. (hereafter referred to as the **Committee**).

The deadline date for acceptance of this Invitation is above. If this Parade Invitation and Participation Agreement is not fully completed and returned to the **Committee** by such date, it indicates the **Organization** may not plan to participate in the **2020 Parade**, which means the **Organization's** place in the Parade may be assigned by the **Committee** to an alternate invitee.

The **Organization** recognizes the **Committee**, just before and during the **2020 Parade**, has authority to interpret its established Regulations and Policies, determine compliance therewith and take appropriate action to enforce such Regulations.

The **Organization**, in consideration of its participation in the **2020 Parade** and in consideration of any support which may accompany such participation, agrees:

1. To indemnify and hold harmless the **Committee** and its individual members from and against any and all actions, claims, damages, injuries, losses, penalties of every name and nature whatsoever arising solely from the **Organization's** negligence in connection with the **Organization's** participation or preparation of participation in the **2020 Parade**.
2. To furnish the **Committee** with a **Certificate of Insurance (COI)**, prepared in conformity with the enclosed Sample COI, affirming the **Organization** is insured by a policy of General Liability Insurance from an approved insurer for a minimum of **\$1,000,000** single limit of liability. Said COI should also affirm, where applicable, the **Organization** carries Workers Compensation Insurance to cover any personnel who work for or provide services, where applicable, to the **Organization** related to the **2020 Parade**.
